If you are interested in being a Gull, please plan to attend one of our meetings which are held the same night as the GMM at 7 PM. Everyone is welcome.

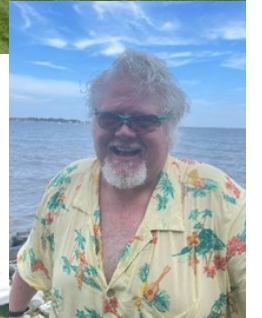

WITNESSED

EASTERN YACHT CLUB ("EYC") and the above-named member ("Member") hereby covenant and agree as follows:

1. Member shall submit to EYC with two complete signed copies of this Boat Slip Lease Agreement, the following: Certificate of insurance or proof of insurance satisfactory to EYC, and payment of slip rent and other charges detailed below prior to occupancy or renewal. This lease shall not be effective until the lease and proof of insurance are accepted and approved by EYC.
2. Full payment of all fees and charges is a condition precedent to the effectiveness of the lease. Failure to remit said payments by term beginning date set forth above may cause forfeiture of the Member's right to occupy the slip noted hereon or to renew the lease in accordance with the EYC Rules and Regulations governing assignment and leasing of slips.
3. Member shall not sublease or assign the leased slip. Member further agrees, in the event of a transfer of ownership of the Vessel occupying the leased slip, to immediately notify EYC in writing of the change in ownership. As soon as practicable after change in ownership, Member shall ensure that the vessel is removed from the slip. Occupancy of the slip by a vessel not owned by the Member shall be considered as Transient Occupancy and shall be subject to daily transient slip fees as may be levied by EYC. The Member shall be responsible for payment to EYC of such transient slip fees unless the occupancy is at the direction of EYC. Failure by the Member to pay such transient fees may revoke this Lease Agreement at the discretion of EYC and any rentals collected hereunder may be treated as liquidating damages by EYC. Transfer of ownership of the vessel to another Member of EYC having a valid Boat Slip Lease Agreement for another vacant slip shall not require the payment of transient slip fees. Slip fees are not refundable.
4. EYC may sublet the leased slip whenever such slip is vacant overnight or is not in use for extended periods.
5. The parties approve the itemization of charges listed below.
6. **This Boat Slip Lease Agreement is subject to all the covenants and agreements (the "Conditions of Use and Occupancy") set forth on the reverse side hereof**, all of which the Member has read, understands, and hereby approves and accepts as a part of this contract Member's failure to comply with the conditions set forth on page 2 hereof shall cause this lease to be null and void, at the sole option of EYC, in which case the Member agrees to promptly remove the vessel. The Member's failure to remove the vessel shall cause EYC to take whatever action is necessary to have the slip vacated. Rentals collected hereunder may be treated as liquidating damages by EYC upon revocation of the Lease Agreement.

IN WITNESS WHERE OF, the parties hereto have caused this Boat Slip Lease Agreement to be duly executed on the date indicated below. By his/her signature, the Member agrees to the terms of the Agreement and stipulates that if the Member fails to comply with any of the provisions of the Agreement, the Member, upon direction of the EYC Board of Governors, will be required to remove the vessel from the Basin within seven days. If the vessel is not removed within this period, EYC will remove the vessel at the Member's expense.

Boat Slip Agreement
"Conditions of Use and Occupancy"

A. As a consideration for this lease, Member agrees that EYC, its agents or employees shall not be liable for any damage, loss, destruction, deterioration of or to said vessel or any article or thing attached thereto or left thereon, or the contents thereof from any cause whatsoever. Member also agrees that EYC, its agents or employees shall not be liable for any personal injuries and/or property damage sustained by the Member or guest as a result of or in connection with the performance of any of the services provided for herein. Member agrees to indemnify and save harmless EYC its agents and employees for any loss, damage or expense incurred by reason of any such damage caused by said Member, loss, destruction or deterioration as aforesaid or by reason of any such personal injuries sustained the Member as aforesaid.

B. Member shall, during the term of this Lease, at Member's sole expense, carry public liability insurance from an insurance carrier acceptable to EYC in an amount not less than \$300,000.00 covering the vessel to be berthed pursuant to this Lease. Proof thereof shall be provided to EYC before the effective date of the Lease as a condition precedent hereto. The policy shall be written in the name of and for the benefit of the Member. Member shall renew the insurance policy when renewal is required and shall provide EYC with proof of each such renewal. In the event of cancellation or lapse of such insurance, Member shall immediately remove the vessel from the basin and grounds of EYC and shall not berth the vessel in the slip until proper insurance is again in force and proof thereof provided to EYC, Member's failure to remove the vessel shall cause this Lease Agreement to be null and void and

C. Member agrees to exercise due care in use of the leased slip, to vacate same in good condition (normal wear and tear excepted) and to indemnify EYC against all claims, actions, proceedings, damages and liabilities, including attorneys' fees arising from or connected with Member's possession and use of the leased slip.

D. Slip rent must be paid prior to the due date shown on the invoice. Signed slip agreements, proof of ownership and insurance must accompany slip rent. Failure to comply will automatically relinquish permanent slip assignment.

E. Member will contact Baltimore Gas and Electric Co. immediately upon being assigned to a slip on either a permanent or temporary yearly basis in order to have electric service billed in the Member's name and mailed to the Member's address. Electric bills for Member's slips will not be accepted by EYC.

F. Member agrees to abide by the following requirements of EYC now in effect and such additions and amendments as may be made thereto from time to time, and further agrees to abide by the House and Ground Rules and Rules governing assignment of slips as published by EYC and as may be amended from time to time.

1. Any condition aboard or around a boat which, in the sole judgment of EYC or its representatives in charge of the Basin, shall be determined to represent a fire hazard, or which reasonably could be expected to result in damage to the piers, catwalks or other boats shall be corrected immediately by the Member to the satisfaction of EYC or its representatives. The use of charcoal or open fires shall not be permitted on boats, piers, catwalks or in parking areas.

2. Catwalks/finger piers and the piers shall be kept clear at all times.

3. Refueling of boats at the piers is not permitted, Draining and/or cleaning of fuel tanks or the use of flammable solvents as cleaning agents are not permitted within the Basin.

4. Garbage, refuse and paper shall not be thrown overboard. All garbage and refuse shall be securely bagged and deposited in receptacles placed on the grounds for that purpose. No privately owned receptacles shall be placed on the piers.

5. Waste oil shall not be disposed of within the Basin except in containers specifically provided for that purpose.

6. Holding tanks or portable toilets may not be emptied into the Basin. All boats containing holding tanks or waste treatment facilities must comply with applicable State and Federal regulations.

7. The use of loudspeakers shall not be allowed.

8. Only vessels in sound condition, floating, presentable as determined by committee and capable of operating under their own power shall be kept in the leased slip. When a boat is in a sinking or unsafe condition in the sole judgment of EYC or its representatives in charge of the Basin, or if the vessel is not capable of operating under its own power, EYC will advise the Member to correct such conditions. If the Member does not take prompt and suitable action to correct the conditions or remove the vessel, or if the Member is not available or cannot be notified, EYC will make arrangements with a marine repair facility in the area to remove the vessel with the resulting charges to be billed to the Member. In the event of an emergency during the Member's absence, i.e., bilge pump failure, leak, parting lines, etc., EYC is authorized to make emergency repairs which will be charged to the Member but without EYC assuming any responsibility for loss or damage to the vessel that may occur as a result of its actions.

9. EYC shall have a lien in accordance with Title 16 of the Commercial Law Article of the Annotated Code of Maryland against the vessel, her inventory, equipment and contents for unpaid sums due for use of docks, facilities or services or for damage to any docks or property of EYC caused or contributed to by the vessel, Member, Captain, or for any other fees, charges or assessments due under this Lease Agreement.

10. Additions or alterations shall not be made to piers, catwalks, electrical equipment or other EYC property without the written consent of the Board of Governors. Handrails, ladders, etc., shall be of a type, construction and style approved by the Board and shall be maintained in a safe condition.

11. Member, upon vacating the slip overnight or longer for a temporary period shall take prudent steps to secure electrical outlets for which he/she is billable for use and shall maintain an inventory of docking lines, hoses, etc. left at the slip. EYC will take steps that may be practical to prevent Member's loss of such equipment during the transient occupancy of the slip but does not warrant against such loss.

12. Slips shall be vacated immediately upon expiration or terminating of the Lease. Any boat occupying a slip without a valid Lease Agreement shall be considered transient and billed at the daily transient rate. All personal property, lines and gear shall be removed from piers and the Basin upon removal of vessel at the termination or expiration of the Lease.

13. All vessels left in the Basin for the winter must have at least one operable ice eater from December 1st through March 31st. Any vessel without an ice eater must be removed. The placement of ice eaters must be coordinated with the Dockmaster; cord/thermostat connections shall be accessible to the Dockmaster without having to board the boat.

Attention All Regular Members, this is a reminder that by September 1st you must have on file a current BOAT/RV slip agreement, active insurance policy, and a completed BOAT/RV inspection sheet.
